The Children's Network of Southwest Florida, LLC, was created in April 2003 as the Lead Agency for child welfare services in Circuit 20.

Children's Network of Southwest Florida is a private, nonprofit organization managing the child welfare system in Lee, Collier, Charlotte, Hendry, and Glades Counties. Our mission is to collaborate with the community to protect children and support families. We oversee the care of over 2,500 abused and neglected children and work with more than 50 social service agencies. Additionally, our Diversion Program assists over 300 at-risk children each month. Founded in 2003, we are committed to creating safer communities and providing children with access to resources and stable, loving homes. We collaborate with the Department of Children and Families to oversee the child welfare system in our region.

## Do caregivers receive financial assistance?

Assistance is available for relative and nonrelative caregivers.

Kinship caregivers are encouraged to become licensed level 1 foster
parents for increased financial assistance.

#### What is Level 1 foster parents?

Level 1 is a Child Specific Foster Home provided by Kin caregivers and includes relatives, non-relatives and fictive kin and allows these families to be paid a foster care board rate. Level 1 foster parents receive the same support as Kin caregivers and are provided access to programs and resources to support them and ensure they are equipped to care for the child(ren) placed in their home. Kinship Specialists work closely with the Level 1 caregivers to provide resources to ensure a safe and stable home such as safety locks for homes with small children, fire extinguishers, and financial resources to assist in placement of the children.

### What other supports are available?

Available supports include: child receives Medicaid to cover medical, dental and therapeutic services; education supports; access to financial resources to help meet the needs of the child(ren); and connections to community services.

#### **Funding for Kinship Caregivers**



- Relative and nonrelative caregivers can apply for TANF and food stamps through DCF Access immediately upon placement.
  - o Food stamp eligibility is based on caregiver's income.
- Relative and nonrelative caregiver funds are not available until the child is adjudicated dependent.
  - Caregiver/Case Manager must apply for relative/nonrelative caregiver funds, they are not automatic.
  - There must be an approved relative homestudy in FSFN for approval.
  - o There is no backpay for relative/nonrelative caregiver funds.
  - The caregiver will receive an enhanced payment for the first 6 months (equivalent to foster care board payment). The rate will then drop down to \$242-292 if the caregiver is not Level 1 licensed.
  - Relative/nonrelative caregiver funds are paid by DCF.
- All relative/nonrelative and Level 1 caregivers will receive a childcare subsidy of \$200 per month per child for all children ages 0-5 or school entry.
  - o Funding is paid by CNSWFL.
- All relative/nonrelative caregivers must be referred to Level 1 licensing.
  - Placement homestudy and change of custody must be completed and child must already be residing with the caregiver for Level 1 licensing.
  - o Funding starts effective the date of licensure.
  - Payment is issued around the 15th of the month for the prior month (prorated if the child is not there for the full month).
  - There is no backpay for Level 1 funding.
- · Funding available to Level 1 caregiver:
  - Monthly foster care board rate: \$570.36 for ages 0-5; \$584.98 for ages
     6-12; \$684.70 for ages 13-17
  - For ages 13-17 there is a 10% Supplemental Room & Board Rate, which calculates to an additional amount of \$68.47 monthly
  - Childcare stipend: \$200 per month per child ages 0-5 (or school entry)
  - Annual back to school clothing allowance per child: \$200 (ages 0-4);
     \$300 (ages 5-17) (CNSWFL added benefit, may not be available in other counties)
  - Diaper stipend: \$30 per month per child ages 0-3 (CNSWFL added benefit, may not be available in other counties)
  - Mileage reimbursement for travel for the child (medical, dental, visitation, meetings, etc.): \$0.445 per mile (CNSWFL added benefit, may not be available in other counties)

Kinship Mavigators

- The purpose of the kinship navigator is to provide support to relative/non-relative caregivers.
- The kinship navigator will read the CBHA (if available) and ensure all referrals are made for the child(ren).
- An intake will be completed by the kinship navigator with the caregiver to identify all needs and services.
- Kinship Navigators will also connect you with community resources. After needs are identified referrals will be made. (Automatic referrals include level 1 and BET intro session).
- The kinship navigator will confirm that the caregiver has necessary information for the child.
   Copy of CBHA, custody letter, and court orders.
- Kinship navigator will complete an exit assessment to make sure all referrals and needs were addressed.
